This letter serves to address the recent offer received from Amanda Estrada on the above-referenced property. We are prepared to accept the offer and release the lien on the subject property once the following conditions are met:

Short Sale Terms:

1. We must receive minimum total net proceeds of \$6,000.00 inclusive of tax escrow adjustments, based on a sale price of \$199,000.00.
2. Closing costs associated with the sale are limited to \$26,855.99, with a maximum of \$11,940.00 in Real Estate Commissions.
3. If the account includes escrow for the payment of your taxes and/or insurance premiums, in order to accurately determine the amount we must receive from closing, no further amounts will be paid or advanced from that escrow account after the date of this letter. Furthermore, any and all funds in that escrow account will be used toward the payoff of your loan.
4. Sellers are to net zero.
5. This transaction may not involve a third party who receives a deed prior to this closing or after this closing and before recording of the deed to the purchaser.
6. Net proceeds must be received on or before July 31, 2013
7. HUD-1 Settlement Statement MUST be faxed 48 hours before closing for approval. Please fax to (866)709-4744 and to [REDACTED] at 866-501-0475. You can also have your authorized agent upload it directly with his or her access to Equator.
8. We must receive full disclosures of any and all affiliations that may exist between Buyers, Sellers, Realtors, Escrow Agents, Attorneys, or any other parties involved in the sales transaction prior to closing.
9. The buyer must be approved for applicable financing.
10. The agreement is not contingent upon any other terms or conditions that may accompany the pending offer.

A copy of the bank wire, HUD1 Settlement Statement, this short sale letter, and any applicable promissory notes must be FAXED to our office at (866) 487-9023 and to [REDACTED] at 866-501-0475 within 24 hours of closing. The HUD1 Settlement Statement must be signed by buyers, sellers, and the settlement agent. Any delay in the receipt of the documents will result in \$100 fee per day along with the per diem interest of \$13.00 each day. Any extension of the closing date will require prior approval.

Note the following:

- **If any of the above demands are not met the Net Proceeds will not be accepted and the satisfaction will be delayed at your expense.**
- **Ocwen Loan Servicing, LLC, as loan servicer for this loan and in agreeing to the short payoff described herein, shall be entitled to the proceeds from any accruing claim, whether filed or not and from any source whatever, arising from the real property described in the mortgage and measured from the date of the mortgage to the date the property is deeded to a third party. This includes but is not limited to casualty insurance proceeds, eminent domain, mineral, gas or oil rights and similar real property benefits. This condition is in consideration for Ocwen Loan Servicing, LLC accepting the short payoff and preempts any provision of the mortgage or note, which may be interpreted to the contrary.**
- **If we receive additional information on the account that would affect our original decision, we reserve the right to withdraw the approval for the acceptance of a short payoff.**

Upon successful completion of the short sale, a release of the lien will be prepared and sent to the appropriate government office for recording. Please note that the release of the lien will not be sent out until the above proceeds are received.

A short sale will result in some portion of the outstanding balance and/or unpaid interest on your loan to be forgiven. This may have tax consequences to you and we encourage you to contact a tax professional to discuss any questions you may have. Upon completion of the short sale, and when we next report the terms and status of your loan to the credit bureaus, we will report that your loan is paid and settled for less than the total amount due.
